- Discussion regarding signs and murals what is allowed by ordinance, what is not essentially signs are allowed, murals are not at this time
- Where does the board concentrate their efforts at this time beautification and wayfinding are important, continue discussion next month
- Slip covers on existing facades, were done in the 70's as a modernization effort, many still remain covering historic brick facades
- Should the board visit with business/property owners about façade grant incentives to paint, refurbish and update their storefronts
- Digital kiosk conversation who would manage agreed that many business owners would advertise on the unit and would be beneficial less stagnant
